

REDUCING OUR

ENVIRONMENTAL FOOTPRINT

Pallets costs have drastically increased over the last two years, reaching all time highs. In August 2021, wood costs have nearly doubled, jumping 98 percent compared to the same period in 2020.




To protect you from this cost-rise and reduce our waste, we have setup a pallet return policy by which pallets can be collected at Armacell collection points as of 1 April 2022. In return, you'll get a payback for reducing our environmental footprint.

The payback conditions and quality-check process are the same across all the EMEA region. See details on page 5 for more information about the countries that are eligible for this collection programme as well as the list of Armacell collection points.

- // A minimum of 50 pallets can be collected by shipment.
- // Pallets can be returned to one of the Armacell collection points (see the map).
- // You organise and pay for the freight when returning the pallets to one of the Armacell warehouses. Upon request, Armacell can also organise it and it will be charged to you.
- // You can get a credit for freight cost if the truck returning the pallets picks up a full truck load of finished goods from our warehouses.
