## Disclaimer

## Image rights

By submitting or uploading the photo as part of this photo challenge, the participant grants Armacell the free and exclusive right to use all copyrights and related rights for the purposes of the challenge (e.g. uploading to the Internet, storing and archiving the photo, presenting the photo, incorporating the photo in other works, etc.) without any restrictions in terms of time, space or content.
